**SECTION 6.1: NOTES & ELIGIBILITY CRITERIA**

*These criteria apply for both **Scheme 1** and **Scheme 2**.*

- This is a **one-time subsidy**. This means that those vehicles which already benefitted from such schemes, **will not be eligible again**.
- The **CO2 emissions shall be less than 180g/km**. It is the applicant’s responsibility to check the vehicle’s emission level.
- Electric or hybrid vehicles will also be considered on these schemes.
- The application for this scheme should be filled in and presented together with all the relevant documents, and shall be submitted by not later than **three months from the date of registration**. Applications received after this three-month period, shall be deemed invalid applications.
- If the application is not eligible as one or more of the criteria are not met, such application will be **refused** immediately and applicant informed in writing.
- All necessary action (including legal action) will be taken to ensure that anyone who benefits from one of these schemes based on erroneous and/or misleading information will refund all, or part, of the assistance received, as may be the case.

## SECTION 6.2: NOTES & ELIGIBILITY CRITERIA

*These criteria apply for **Scheme 1** only in addition to Section 6.1.*

- The subsidy is of not more than 20% on the price of the purchased vehicle, which **shall not exceed €60,000 excluding all taxes and registration costs**. If a vehicle exceeds the €60,000 capping price, the 20% subsidy would still be calculated on the maximum of €60,000.
- The vehicle should be strictly **drive from wheelchair**. This means that the vehicle shall have an electric ramp at the back where a wheelchair driver can access it with the wheelchair and position himself in front of the steering wheel to drive the vehicle.
- The vehicle may be purchased new or second-hand.
- The vehicle may or may not be registered in Malta.
- The vehicle shall **only** be registered in Malta on the name of the person with disability driving the car.

## SECTION 6.3: NOTES & ELIGIBILITY CRITERIA

*These criteria apply for **Scheme 2** only in addition to Section 6.1.*

- The subsidy is of not more than 10% on the price of the purchased vehicle of which **shall not exceed €25,000**. If a vehicle exceeds the €25,000 capping price, the 10% subsidy would still be calculated on the maximum of €25,000.
- The vehicle shall be modified with a wheelchair accessible ramp and/or lift.
- Furthermore, the vehicle shall be purchased **second-hand only, pre-owned and already registered in Malta or being purchased from abroad**. In cases where the person with disability is deceased, the heir has to first apply for transfer of ownership prior to selling the vehicle to another person with disability.
- The vehicle can be registered on the name of the person with disability or parent/guardian/relative living in the same house. A copy of the Identity Cards needs to be presented with the application in case the vehicle is registered on parent/guardian/relative on behalf of the person with disability.
